II. Agreement

In consideration of my receipt, from Next Step, of a non-qualifying entry into the Falmouth Road Race ("Race"), and my eligibility to participate in any events related directly or indirectly to the Race ("Related Events"), I agree to raise a minimum of \$1,000.00 for Next Step. I agree to submit the guaranteed minimum to the Next Step office by September 15, 2019. I understand that should I be injured, or for any other reason, do not run in the Race, I am still responsible, and agree to pay my fundraising commitment. In the event that I do not raise the minimum amount of \$1,000, I give permission for my credit card to be charged the remaining amount due. (Credit card information provided below)

***You may relinquish your place on the Next Step Team without penalty by May 1, 2019 at 11:59pm.**

After that date and time, you are responsible for the minimum fundraising requirement of \$1000.00

Any funds raised up to that point remain with Next Step.

III. Release and waiver of liability, assumption of risk, photo release, indemnification

In addition to the above:

1. I acknowledge that running a road race is a potentially hazardous activity and may pose significant risks and dangers of serious bodily injury or even death ("Risks"). These risks may be caused by me or by the actions or inactions of others participating in the Race, the condition in which the Race takes place, or the negligence of the Released Parties named below; and there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Race or in any Related Events.

2. I represent that I am at least 18 years old, in good health, and am medically fit and able to participate in the Race. I agree to conduct myself in a safe and prudent manner. I agree to abide by all event rules and any decision of a race official relative to my ability to safely complete the Race.

3. I consent for emergency medical treatment to be given to me and acknowledge that I will be responsible for the cost of such treatment.

4. I agree to be photographed or otherwise have my image and voice recorded during my participation in the Race. I understand that these recording or photographs may be used for any purposes related to the business of Next Step or the Falmouth Road Race.

5. I hereby, for myself, my heirs, executors, and administrators, waive, release, discharge, covenant not to sue, and agree to indemnify and hold harmless, Next Step, the Falmouth Road Race, the title sponsor New Balance, and each of their subsidiaries and affiliates, their respective administrators, directors, officers, agents, volunteers, and employees, other sponsors, advertisers, other participants, and if applicable, owners and lessors of premises on which the Race or Related Events take place ("The Released Parties"), from all liability, claims, demands, or losses of any kind on my account related in any way to my participation in the Race or Related Events, including any such claims which allege negligent acts or omissions of the Released Parties.

I have read this Agreement carefully, fully understand its terms, understand that I have given up substantial rights by signing it, and that I sign the Agreement of my own free will and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
